Facility: Six (6) lanes, 25 yard indoor pool, backstroke flags, non-turbulent lane dividers, 3.5 feet minimum depth. Height of blocks is 30 inches. Depth of pool at starting blocks is 12 feet. Timing will be with 3 manual watches per lane for 25 yard events. All other events will use Colorado electronic timing system with touch pads and two watch back-up per lane.

Rules: Official 2007 Short Course rules shall prevail at this meet. Coaches must display their current membership cards while on deck.

Eligibility: Swimmers must be registered with USA Swimming. Age is as of Jan. 13, 2006.

Schedule: Morning session warm-ups will start at 7:00am. Sprint lanes will be opened at the discretion of meet director. Meet begins at 8:05am. Afternoon session warm-ups will begin immediately following the conclusion of the morning session. The afternoon session will begin 65 minutes after completion of the morning session.

Entries: Swimmers are limited to a total of four (4) individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in yards. This will be a pre-seeded meet. Any special requirements for swimmers should also be noted on the entry forms.

Entry Fees: Fees are \$4.00 per individual event, \$10.00 per relay. Add \$2.00 LSC Splash fee per each individual swimmer.

Entry Deadline: Completed entry forms, waiver, and fees must be received by the Meet Director no later than December 22, 2006. Late entries will NOT be accepted. This meet will be run using Hytek Meet Manager software. Please include hardcopy with all disk entries. Teams who submit entries via disk may pick up their final results disk at the conclusion of the meet. Entries may be e-mailed (Hytek format only) to Jay Van Cleave at jvancleave@wi.rr.com.
