- Host: Watertown Aquatic Team (WAT)
- Date: Saturday, Dec. 9th, 2006
- Schedule: Meet will start at 8:35 AM
Warm-ups for the AM session will be from 7:30am – 8:30 am.
7:30 – 8:00 AM Circle swim all lanes.
8:00 – 8:30 AM Circle swim lanes 1, 2 & 3.
Push/Pace 50 s lanes 6, 7 & 8.
One way sprints lanes 4 & 5.
This procedure will be repeated for the afternoon session.
Warm-ups for the PM session will not begin before 11:00 am.
- Location: Fort Atkinson High School

Fort Atkinson, WI
- Pool: Eight (8) lanes, 25-yard pool with non-turbulent lane markers, backstroke flags, and 28” blocks. Pool depth is 3.5 ft. at its shallow end and 8 ft. at its deepest end. Ample parking available in the high school parking lot and seating in the pool area. **The starting block pool depth is 8 ft.**
- Timing: **Colorado electronic timing system** with touch pads and manual back-up timing buttons and horn start. Each lane will have two timers with electronic stopwatches. All events will be timed finals.
- Meet Format: Clerk of Course will be staging 8&U swimmers near the starting blocks. All other swimmers must be at the starting blocks at the start of their events.
- Deck Seeding: Deck seeding will be allowed only to the limit of filling partially filled heats. A \$5.00 charge per event will be assessed for deck seeding. Deck seeding will close at 8:15 AM for the AM Session and 15 minutes before the PM Session starts. Swimmers unable to prove USS membership will be charged a deck-registration fee of \$60.
- Rules: 2006 USA-S and Wisconsin Swimming Rules shall govern this meet. All swimmers must be USS registered. All out of state swimmers must bring their USS card to the meet. Swimmers not reporting to the blocks at the start of their event will be scratched. Relays: First and last names of competing swimmers and order of swimming must be listed on relay card along with age, prior to swimming the relay. No Recall Starts.

Entries: Completed entry forms, signed waiver, and fees must be received by **Friday Dec. 1st, 2006**. Preferred method of entry is by diskette in HY-TEK COMMLINK format. Diskettes **MUST** be accompanied by a hard-copy listing. Current USS ID number **MUST** be included on the entry form. All deck entries must be able to prove USS membership. Out of state swimmers must show their current USS card prior to swimming.

Entry Limit: Only the first 1200 individual entries will be accepted. Entries not accepted will be notified by phone as soon as possible. SWIMMERS ARE LIMITED TO **FOUR (4)** INDIVIDUAL EVENTS PLUS **TWO (2)** RELAYS. **If USA swimming timeline 4 hour rule per session is exceeded when all entries are received, events will be limited to the top 12 seed times. Coaches will be notified so they can change event for swimmer.**

Age Groups 8&U, 10&U, 11-12, 13&O; Age as of Dec. 9, 2006

Entry Fee: Individual Events: \$3.00
Relays: \$10.00
Splash Fee: \$2.00

Fees are not refundable unless the meet is full.

Coaches Packs: Coaches packs will be held for pick up in the pool office. A current USS Coaches membership card will be required to receive each pack.

Awards: Awards for relay events will consist of ribbons for **1st-6th** place. Awards for individual events will consist of medals for **1st-3rd** places and ribbons for **4th-12th** places. Heat winners for 8&U and 10&U events will receive either a ribbon or an award. Individual swimmers must claim their own awards. Group distribution of awards to coaches will be permitted. Awards will not be mailed.

Admissions: Admission for persons 12 and over will be \$3.00. Heat sheets will be available for \$2.00.

Adaptive Swimmers: Please notify the meet referee so that any special needs may be accommodated.

General Information: One copy of final results will be given to each team.

Additional copies are available for \$5.00.

Radios are permitted only with the use of headphones. TV's are not permitted in the pool area.
