## 2008 STAR Cinco De Mayo Swim Meet

WI Sanction #2008-107WI

DATE: Saturday, May 3, 2008

LOCATION: Stoughton High School Pool  
600 Lincoln Ave  
Stoughton, WI 53589

Pool entrance in back of High School; use the back parking lot off of Devonshire Rd.

FACILITY: Stoughton High School Pool is an 8-lane, 25-yard pool with non-turbulent lane markers and backstroke flags. Pool depth is 12' 5" at starting end, with 30" starting blocks. The non-starting end of the pool is 3'6", thus the 2nd and 4th leg of the 100Y relays for 8 & U will start in the water.

SCHEDULE: Morning session warm-ups will be 7:30 am- 8:30 am. The meet will start promptly at 8:35 am. Afternoon session warm-ups will begin 30 minutes following the conclusion of the morning session, but not before 11:00 am and last for one hour. A fifteen-minute break will be taken prior to the 500Y Free being swum. Fly over starts will be used in this meet.

WARM-UPS: First 30 minutes will be general warm-up/circle swim.  
Last 30 minutes: Lanes 1, 2, 7, & 8 will be circle swim. Lanes 3, 4, 5, & 6 will be on-way sprints.  
Sit and Slide entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition.

ENTRIES: Swimmers may compete in four (4) individual events per day plus 2 relays. Swimmers must be USA Swimming registered in order to enter. We will accept 300 swimmers to this meet. The 500 free is a positive check-in event and will be limited to the top 16 swimmers in each event. Any swimmer unable to compete due to the limitation will be refunded the entry fee for this event. Entries not accepted will be notified by phone as soon as possible. This meet will be run using Hy-Tek meet manager. All teams are encouraged to submit entries in the Hy-Tek format.

ENTRY DEADLINE: The entry chair must receive a completed entry form, signed waiver and fees no later than **Wednesday, April 23, 2008**. No entries will be taken over the phone. However, email entries are encouraged and can be sent to Sally MacLaren-Meuer at [sallymaclaren@yahoo.com](mailto:sallymaclaren@yahoo.com). Unless you have received a confirmatory email from the above address, it has not been received! Meet entry fees and waiver must be sent via standard mail and postmarked by the entry deadline.

- DECK SEEDING: Deck seeding will be allowed only to the limit of partially filled heats. An \$8 per event charge will be assessed for deck seeding. Deck seeding will close once the meet starts for the both morning session and afternoon session.
- ENTRY FEES: \$2.00 LSC splash fee per swimmer, \$4.00 per individual event and \$12.00 per relay.
- TIMING SYSTEM: All events (with the exception of 25-yard races) will be timed using a Colorado Timing System with horn start, touch pads, one button, and two watches as backup. 25-yard races will be timed with two (2) stopwatches.
- DISABLED: Please indicate on the entries form any special needs for those athletes.
- SWIMMERS: Requiring assistance should also, inform the head officials of those needs prior to the start of the meet.
- AWARDS: Awards for relay events will consists of ribbons for 1<sup>st</sup> thru 3<sup>rd</sup> places. Awards for individual events are ribbons for 1<sup>st</sup> thru 12<sup>th</sup> places. Heat winners for 8&U and 10&U events will receive a reward. Awards will not be passed out to individual swimmers; coaches should pick up their award packages at the end of the meet. Awards will not be mailed.

2008 USA Swimming and Wisconsin Swimming LSC rules apply to this meet.
- MEET CONDUCT: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition.  
In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.
- ADMISSIONS: **\$5.00 for ages 10 & up, each paid entrant will receive a complimentary heat sheet. And be entered in a 50/50 raffle. You may purchase additional raffle tickets if you wish.**
- FINAL RESULTS: One electronic copy of meet results will be sent to all participating teams. One hard copy per team is available upon request. All others wishing to obtain hard copies may order one for \$5.00

CONCESSIONS: Delicious hot and cold foods will be available for purchase throughout the meet. Food and beverages will not be allowed on the pool deck.
