

2007 Team Wisconsin Honor Code - Swimmer

As a member of Team Wisconsin, I understand that I represent Wisconsin Swimming, Inc. my Club, my parents, as well as myself. I am honored to be a member of Team Wisconsin and to represent Wisconsin Swimming in the Central Zone Long Course Swimming Championships.

1. I understand that the possession or use of alcohol, tobacco products, fireworks, weapons, or controlled substances is prohibited.
2. I will adhere to curfews established by the Team Wisconsin staff each day whether or not I am finished competing in the Meet.
3. I will compete in all events in which I am entered including any Finals and/or relays; I will attend all Team functions including meetings, practices, Team photo appointment, any All Zone activity, etc. unless excused by the Team Manager or Head Coach.
4. I will wear the Team Wisconsin uniform (t-shirt and jacket) for the Team picture; I will wear the Team t-shirt or jacket on the Awards Stand and in the Participant Parade.
5. I will not participate in any illegal or inappropriate behavior, including gambling, that would detract from a positive image of Team Wisconsin or be detrimental to its performance objectives.
6. I will display proper respect and sportsmanship toward coaches, chaperones, officials, administrators, other competitors, and the public.
7. I will do nothing that would put me, a Team member, or anyone else at risk or in danger.
8. I will adhere to all Team Rules as specified at Team meetings and in written Team information.

Implementation

In signing this Code, I agree to comply with all of the provisions the Honor Code of Team Wisconsin as established by Wisconsin Swimming, Inc. for the duration of the trip, until the Team officially disbands.

Failure to comply with the Honor Code and Team Rules may result in disciplinary action under the provisions of Wisconsin Swimming Rules and Policies and USA Swimming 2006 Rules. Such discipline may include, but not be limited to:

- Dismissal from the Team and immediate return home at the expense of the swimmer's family.
- Scratching from one or more events or all events of competition.
- Suspension from future USA Swimming and Wisconsin Swimming competition.

Any appeal from any disciplinary action shall occur in accordance with Wisconsin Swimming Rules and Policies and USA Swimming 2006 Rules. Parent and athlete MUST both sign below!
